DESCRIPTION OF OFFENSE: Murder / Homicide by child abuse (20Y to Life)

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on or about February 27, 2016 one Angela Renee Blackwell did commit the crime of Homicide by Child Abuse by committing child abuse and/or neglect, and the child abuse and/or neglect did result in the death of [REDACTED] (date of birth: [REDACTED] 2016) and the death occurred under circumstances manifesting an extreme indifference to human life. The defendant did place her child, the victim, inside a working refrigerator and closed the door to the refrigerator. It was about three hours before she removed the child from the refrigerator and sought medical attention. This incident occurred at 534 Rose Street, Chester, South Carolina, where the defendant and child victim resided. Probable cause is based upon investigation by Law Enforcement which includes but is not necessarily limited to direct observation by Law Enforcement, witness statements, photographs taken by Law Enforcement, and medical records.
